The Sisters of Saint Casimir of Chicago is founded by Venerable Servant of God Maria Kaupas in Scranton, PA.

The Sisters of St. Casimir purchase Maple Lane Farm to be used as a retreat for the Sisters and a school for young girls. They boarded in Regina Hall and walked to Maria Hall for classes.

2006-2007

The school expands into the first two floors of the former nursing home. (South wing)

JANUARY 2017

The Sisters of St. Casimir give \$1 million to the school for expansion.

MAY 2017

The Sisters of St. Casimir gift the school campus to the school.

SEPTEMBER 2019

Construction on the new Performing Arts Center (PAC) is complete. This expansion also includes renovations to the school's main offices and front entrance to provide additional security.

Our Facilities Committee continues to evaluate the needs and priorities of the school to determine and plan a facility that supports our Mission today and for the future.

A History of Our Campus

With the construction of the Motherhouse completed in Chicago, Sr. Maria is elected first Superior General, a position she held until her death.

Because of a growing student population, the Sisters build a new school (current school building) and move to a traditional day-school structure.

DECEMBER 2017 & AUGUST 2018

Villa Joseph Marie receives two redevelopment grants from the state for STEAM expansion, totaling \$1.5 million.



At the start of the 2021-2022 fiscal year, several factors required Villa to press pause on the forward momentum of the planned STEAM project. COVID was one factor. Another was our Board of Director's request for time to carefully review the financial feasibility of moving forward on this project given Villa's current \$4.9M outstanding debt on the Performing Arts Center. The third was the necessity to review Villa's facilities in light of current and future curricular needs.

As it turns out, these pauses were fortuitous, as they gave us time this year to develop a Master Plan for Villa's facilities development across all disciplines and all 125,000 square feet of our existing physical campus. The vision was the creation of an aesthetically pleasing and missionaligned campus that perfectly supports the needs of the Villa community now and in the future through a collaborative, diverse, and sustainable process. This plan is unique in

Villa's history for three reasons. First, in the past, Villa has developed numerous designs for various spaces, but these designs have occurred without integration into an overall vision for the school. The Master Plan integrates Villa's needs for STEAM infrastructure, athletics, the arts, theology, and the humanities into a cohesive plan for the school's plant development over the next 10-15 years. Second, the development of this plan was the result of the work of a diverse and comprehensive stakeholder group that included parents, staff, faculty, students, our new facilities director, and alumnae. Third, prior to beginning renovations, we will have a sustainable fundraising process in place to avoid any additional long-term debt to Villa's financials. With the final stages of the Master Plan nearing completion, this committee, in conjunction with the Board, has agreed that STEM is the top priority for the next phase.





YOU MADE AN IMPACT ON OUR STUDENTS AND our community

As we enter Villa's 90th anniversary year, I find myself feeling extraordinarily grateful for this special place I have come to call home over the last eight years. I am grateful for the students I have met and the encounters with them that have left me with a better understanding of what it means to be a Christian. I am grateful for the colleagues I am honored to learn from and work alongside. I am grateful for the individuals I've had the privilege of meeting during day and overnight service experiences to Chicago, Mount Carmel, Blessed Sarnelli Community, Caring for Friends, and Churchville Nature Center, to name a few. It is because of the generosity of our alumnae, our Villa families, and our benefactors that Villa's ministry program continues to offer faith-based programs where students can build community and encounter Christ in each other and those they serve.

I think of some of our recent alumnae who, while at Villa, were provided opportunities to deepen their faith through liturgies, retreats, and service experiences. As these seeds of faith, sown on the strong foundations of their families, grew here at Villa, they left ready to carry on Villa's mission in the broader world. alumnae who are living their own vocational callings as educators in Catholic schools; who volunteer their time with local charities; who are doing a year of volunteer service; who serve as mentors to our Villa students; who use their college degrees to travel to poverty-stricken areas of our world to educate and care for God's people.

Brigid Conmy '18 is one such alumna. Brigid shares, "During my six weeks in Uganda, I was able to serve the people of Kyarusozi and work in the medical clinic that is founded by the Sisters of the Holy Cross. I fell in love with service and health care during my time at Villa and I truly feel called to live out this vocation all over the world. I try to serve by helping those in need and also learning from all of the amazing people that I encountered during my time in Uganda." Brigid's message is only a glimpse of the long-term impact of a Villa education, of the fruit that is grown from the faith foundations and service experiences they participated in while at 1180 Holland Road.

This past school year, 100% of Villa students were involved in the faith-life of Villa through liturgies, prayer services, and retreats. Additionally, 90% of Villa students participated in optional ministry programs. Our Mission and Ministry program offered 170 leadership positions and 42 optional service and retreat programs, allowing our students the opportunity to practice servant leadership, while gaining a better understanding of their own God-given gifts and talents. The 6,000 service hours submitted by our students this year is evidence that our young women are striving to discern ways they can make an impact on our local community. Without the prayerful and financial support of so many benefactors Villa would not be able to provide these offerings to our students.

Mother Maria Kaupas wrote, "Trust God in your difficulties and place the future in God's hands... have great concern for the needs of one another. As our Lord asks: 'Love one another as I have loved you." Thank you for providing an abundance of opportunities for our students to love one another as Jesus loved us. Our students continually amaze me with their desire to serve as God has called them to, to put their faith into action and to have hearts filled with concern for the needs of their sisters and brothers in Christ. I am proud to know and work with our Villa students who carry out the legacy of our foundress and of our Sisters so well, doing all things in the spirit of Always more, Always better, and Always for the love of God and neighbor.

Mother Maria, Pray for Us. May God continue to bless you and your families. May God continue to bless Villa Joseph Marie High School.
